- Council is leaving gates open during road works. He had spoken to the Police and Stock Squad. It is an offence to leave gates open. An officer assured him it would be rectified and it hasn't been looked at.
- 2. A gate was broken on Haydon by a contractor this is a bad look for Council.
- 3. Work along pipeline to Karumba through our block, dirt has been dumped at every turn off and crossing. This is petty and spiteful.

6.1 Works Report

7.2 Water Status Report for October 2012

During, October 2012, 98.8 ML of water was pumped from Glenore Weir. Bore water pumped was a total of 4.9 ML. Total water received at the water treatment plant was 103.7 ML. This was more than last month.

Due to the increased water consumption and the drop in water level at the Glenore Weir, back-pumping was started again on 29 October 2012.

Glenore Weir level on 30 October 2012 was 5.54 AHD. The level of the weir on 30 September 2012 was 6.08 AHD.

Consumption for Normanton was 3.30 kL/day per connection and Consumption for Karumba was 3.53 kL /day per connection.

A total of 10 tests were conducted on water samples from the reticulation system for E-Coli during the month of October 2012. No E-coli was detected.

- 2. would detrimentally impact Council's future plans and intentions for the area, including beautification of the entrance to the newly constructed Karumba Walkway;

9. CORPORATE SERVICES REPORTS

9.1 Monthly Financial Report for Period Ending 31st October 2012

The Monthly Financial Report has been prepared for the period ending 31st October 2012.

The following is a summary of major variances and points to note.

Income Statement:

Interest Revenue is showing 22% of total budget. This is well below prorata budget (\$125,000 short) due to the use of fixed term investments which have not yet matured and lower average cash balances due to delays in recoverable works claims being collected.

There is a significant variance between recoverable works revenue (\$13.4m) and recoverable works costs (\$20.1m). This is caused by timing differences between the work being performed and the claims submitted. No claims have yet been submitted during November. This area is being investigated in detail as to what the causes are for the delays in making claims and improvements will be made in the very short term. Engineering is currently involved in a benchmarking process with QRA to find common ground.

There is significant shortfall in grants and subsidies than the average expected for the period. We will receive \$2.3m in Financial Assistance Grant for the full year instead of \$4.7m shown in the budget. This is caused by changes in Federal Government policy with Council receipting half of allocation in advance.

Administration and Governance is showing a negative expense due to very high oncost recoveries. A review will be conducted in November.

Environmental costs are well below budget due to the pest management program not yet being fully implemented and the refuse collection costs tracking well below normal costs.

Net plant operations is showing a greater negative expense than forecast for this time of year. This is directly related to the higher than prorata amount of recoverable works done to date and thus the higher levels of plant utilisation.

General Notes:

Council auditors arrived in early October and conducted the onsite audit of the Annual Financial Statements. This is due to be finalised by end of November.

An amended budget is being prepared and should be presented to Council at the December meeting. While there is unlikely to be major changes to the total operational expenditure, there will be changes to the capital program.



Recruiting for the new Director of Corporate Services has commenced and we are hopeful of finding a suitable candidate.
