7.2 Water Status Report for November 2013

During November 2013, 51.8 ML of water was pumped from Glenore Weir. Bore water pumped was a total of 2.0 ML. Total water received at the water treatment plant on 30 November 2013 was 53.8 ML. This was less than last month.

Glenore Weir level on 30 November 2013 was 2.09 AHD, the level of the weir on 30 November 2011 was

-0.559 AHD.

Consumption for Normanton was 1.95 kL/day per connection and Consumption for Karumba was 1.72 kL /day per connection.

A total of 10 tests were conducted on water samples from the reticulation system for E-Coli during the month of November 2013. No E-coli was detected.

The total sprinkler ban was discontinued on 25 November 2013 after rain events replenished water supplies. Phase I water restrictions are now in place with a public notice issued. It should be noted that water restriction compliance in the communities of Normanton and Karumba were exceptional during the total sprinkler ban.

8. CHIEF EXECUTIVE OFFICER REPORTS

8.1 Installation of Flood Gauges

Council has received funding from the Queensland Government in the sum of \$380,000 (Excl. GST) for the installation of six (6) flood gauges throughout the Shire. Council sought tenders for the supply and installation of the flood gauges. The total cost of the six (6) gauges based on the prices provided by the recommended supplier is \$240,840. The recommended supplier has also included a price for a seventh gauge at a cost of \$27,240.91. This would leave a balance of \$111,919.09 unexpended funds.

Based on the costs provided by the recommended supplier, approximately three (3) further gauging stations could be installed in order to expend the balance of the available funding.

9. CORPORATE SERVICES REPORTS

9.1 Monthly Financial Report for Period Ending

The Monthly Financial Report has been prepared for the period ending 30 November 2013.

The following is a summary of major variances and points to note.

Income Statement:

As at 30 November 2013, 41.6% of the financial year has elapsed, and whilst the Income Statement indicates a deficit in the *Net Operating Surplus*, the bulk of this relates to yet to be reimbursed NDRRA Flood Damage Restoration works (there is approximately \$12.2 million in yet to be reimbursed works associated with the 2011 and 2012 Events) and ongoing Council Capital Expenditure projects. If these are separated from ordinary activities, Council would be reporting an operating surplus with rates, financial assistance grants and other grants paid in advance.

First half rate levy has been processed with the notices issued on the 26 August 2013, as at the discount closing on the 24 September 2013 approximately 10% remains outstanding from current levy.

General Notes:

The 2012/2013 Annual Financial Statements have been received and signed off by the Queensland Audit Office; these were adopted along with the 2012/2013 Annual Report at the November Ordinary Council meeting. Work is underway to have a revised budget brought before Council at the January Ordinary meeting that incorporates the carry forwards from the previous Financial Year along with the stated balances from the 2012/2013 Annual Financial Statements.
