## 3.2 CARPENTARIA LAND COUNCIL ABORIGINAL CORPORATION SERVICE AGREEMENT

#### **Executive Summary:**

The CLCAC Normanton Land and Sea Rangers ("Rangers") are supported by funding from the State of Queensland and the Australian Governments. The Rangers also gain revenue from "fee for service" agreements with local governments, pastoralists and University research programs. Operating out of Normanton, the Rangers undertake various activities related to the management of traditional land and sea country. The Rangers are qualified and credentialed to carry out a number of different land and sea management activities including pest management through the use of baits.
