

4.1 TENDER 20-0514 DESILTING OF THE NORMANTON WASTE WATER (SEWAGE) LAGOONS

Executive Summary:

A request for tenders for the desilting of the Normanton Waste Water (Sewage) Lagoon (EFT20-0514) closed on 26 August 2020 with four (4) tenders received. The tenders have been assessed with a 70% price weighting and 30% non-price weighting.

The tender assessment panel has reviewed the seven (7) tender submissions received for the construction of the Normanton Raw Water Irrigation Network (CN: 20-0515). One (1) tender was received from a local contractor and six (6) tenders were received from non-local contractors. The tenders have been assessed with a 60% price weighting, 30% non-price weighting and 10% local preference weighting.
