Executive Summary:

Council has received interest from suppliers for plant to assist with the 2022 Construction season outside the original tender T22/0549 called in January 2022. This interest is because of not being able to source graders locally under the Pre-Qualified Supplier Listing.

RECOMMENDATION:

That Council authorise the acceptance of the additional quotes submitted recently, outside the original call for tenders, from suppliers that are reasonably available to the Council in accordance with section 235(a) for the Local Government Regulation 2012; and

Delegates authority to the Mayor and Chief Executive Officer to accept additional quotations for plant and equipment, outside the pre-qualified supplier listing, necessary to complete the works for the 2022 Construction Season where plant is not reasonably available from the original tender list, where any additional plant sought aligns with the sound contracting principles outlined in the Act.

Background:

Council called for tenders for the 2022 Construction Season Pre-Qualified Supplier of Plant under Tender Number 22/0549 on Monday 24th January 2022. The Tender was managed through Vendor Panel and while due to close on Tuesday 15th February 2022 was extended for an additional week.

Tenders were evaluated and a pre-qualified list was established.

The construction season has started, and the Works Manager has advised that after approaching suppliers available on the listing we require an additional four graders to undertake and complete works within the construction works program.

Four separate approaches have been received for the additional Graders necessary to join the works program and some of the responses are attached to this report. Council will note that one of the proposals included a grader to be rented and offered for the season, we have requested ownership in the past.

Executive Summary:

Council has received several requests from local contractors following the recent increases in fuel prices which is impacting the local providers.

RECOMMENDATION:

That Council consider the information supplied and provide direction on a proposed method of implementing a system for managing the fluctuations in fuel pricing impacting contractors.

Background:

Fuel pricing is fluctuating and in the most is rising consistently across the Nation. This is having a direct impact on the local businesses that are providing service to the Carpentaria Shire Council for the 2022 DRFA Construction Season.

The question of fuel levy was raised during the Call for Tenders and a copy of the tender questions and responses provided are included in the report.

Correspondence has been received from two separate contractors and a third has met with CEO to discuss impacts of the fuel pricing on business and service delivery at current pricing submitted with RFT.

Council has been in discussions with the Queensland Reconstruction Authority (QRA) in relation to the impacts of the fuel pricing and no statewide proposal of a fuel levy is proposed. Council has also been in discussions with other Councils to ascertain the impacts and how these are being monitored and whether any relief in pricing has been proposed.

We are awaiting information from several Councils in relation to what they have implemented or are considering implementing to assist in forming an action for Carpentaria. It will be a better proposition to take to the QRA if we are all implementing a similar approach to the issue of fuel increases.

Once the information is received from Mareeba and Charters Towers it will be distributed to Councillors for consideration and discussion at the Special Meeting on Tuesday Afternoon.

Just a bit of further information regarding fuel price increases to add into the mix. The RACQ Fair Fuel Price reports seem to support Peter's claim of price increases with the annotated attached excel summary between February and May showing approximately a 17% increase since the closure of the tender (note – I believe these are average bowser prices – not wholesale).

A quick note – Peter raised this same question during the supplier query period and was advised that there would be no fuel levy and the risk should be factored into the price.

Dear Brad,

I am writing to you to provide an overview of the domestic and international drivers of the high fuel prices seen in the Australian market through 2022. Based on IOR's 38 year history working in the oil exploration, refining, and fuel distribution business we are pleased to share our perspectives on the market, and unfortunately to advise you that we do not see the challenges abating this year.

Diesel prices at the Terminal Gate in Australia have increased by approximately 80cpl since the start of the year, or over \$1.00 when accounting for the 22.1cpl reduction in Federal Government fuel excise delivered on 30 March 2022, which is a ~70% price increase.

For example, the Terminal Gate Price for Ampol in Brisbane, which is published daily on their website, was 150.51cpl on Monday 3 January. The published price for tomorrow 23 June is 232.77cpl, which would be 254.87cpl at full excise.




Figure 1: Mean of Platts Singapore (MOPS) prices for diesel since January 2022 (source: SP Global).

For your context, the Mean of Platts Singapore (MOPS) is the international price index typically followed by local fuel importers in Australia – see Figure 1. Overnight (21 June 2022), the MOPS price for diesel reached US\$186 per barrel, which is now the highest it has ever been and is more than double the price on 3 January.




Figure 2: Illustrative breakdown of contributions to Australian fuel prices.

The MOPS price is the major driver of local fuel costs, but not the only one. Figure 2 is a simplified illustration of the different factors that go into Australian fuel prices. Across the board we have seen upward pressure on each of these price drivers since the start of the year.

Looking forward, the 'delivered cost' of fuel, which is the cost to take fuel from the import terminal or refinery to the customer, is likely to feel more pressure from localised inflation, interest rate increases, and growing labour costs. Further, the fuel excise which was cut in half by the previous Federal Government in March will be reinstated on 1 October 2022, adding a further 22.1cpl on the bowser price.

Given the ongoing fuel price pressures, IOR has been urging our valued customers to ensure they are adequately protected by fuel levies built into all contracts, wherever possible. The significant changes to fuel prices through 2022 have materially increased costs to operate in the Transport industry.

In our experience, many of our customers are using the Transeco index for long-term contracts. IOR has been advocating for our customers using Transeco or similar indices to ensure that the changes in freight rates are applied in arrears if possible, given the volatility and speed of change we are seeing.

About IOR

IOR is a fully integrated fuel company with operations across refining, importing, distribution, and fuel management. With our head office in Cannon Hill, QLD, we operate across Australia, supporting regional areas and B2B customers, particularly in the long-distance transport, resources and agricultural industries. The core business is running a network of unmanned fuel stations across regional Australia, with 94 truck stops and 27 airports, and a further ~500 remotely managed fuel tanks deployed on behalf of our customers. IOR acquired and is operating an 81ML fuel import facility in Port Bonython, SA, and serves much of the major mining industry in the region. In South-East QLD, IOR is currently building ~110ML import terminal in Lytton, QLD, to secure fuel supplies for our major markets. The Lytton facility will be operational by June 2023.
