Introduction

With the current global challenges impacting business and community groups around the world, Governments and other funding providers are quickly moving to provide two types of support:

- 1. Immediate and direct funding to help alleviate the financial impact to business.
- 2. Longer term measures that seek to reduce the long-term economic impacts.

Provided below is a summary of the main grant programs that have been released in the last month or so. Some programs have already closed, so we have not included those and others are very specific, such as funding support for airlines, so we have left off those types as well.

Remember, not all grants and funding are the same. While we often refer to all funding programs as grants, that is not quite technically correct, because the mechanism used to deliver funds may vary, and these each have their own description. When you find a program that looks like a good fit for you, make sure you check to see how the funding is delivered. Here are some of the possible options:

- Rebates
- Duty Concessions
- Tax Concessions & credits
- Vouchers
- Interest Free Loans

Most programs fall into two categories:

- 1. Entitlement programs you are eligible to get these programs if you meet the qualification criteria. Many of these programs rely on self-assessment and will only be assessed much later on, once you have received and no doubt, spent the funds. So, it's really important you check to make sure you fit, otherwise you might have to pay it back. Some of these programs are run through the tax system, so you may wish to use a qualified tax practitioner.
- Competitive grants where there is a limited amount of funding, it will go to the best applications

 those deemed most worthy, who fit best with the criteria and will deliver the best result. Since you are competing for funds, you really need a compelling submission and to stand out from the crowd.

Remember, it's not about you! As much as you need the funding, as desperate or worthy as you may be – the funder is providing funding for a reason. If, and only if, you meet their criteria and the policy behind their program, will you be eligible.

National Programs

COVID-19 National: Business, Non-Profits – Boosting Cash Flow for Employers

Status	Open
Funding	Max \$100,000
Location	National

Overview

This program aims to provide temporary cash flow support to small and medium businesses and not-for-profit organisations that employ staff and have been affected by the economic downturn associated with COVID-19 (novel coronavirus). It forms part of the Australian Government's Coronavirus Economic Stimulus Package which aims to support households and businesses and address the significant economic consequences of the Coronavirus.

The Government will provide tax-free cash flow boosts of between \$20,000 and \$100,000 to eligible businesses, delivered through credits in the activity statement system, when eligible businesses lodge their activity statements.

Eligible businesses do not need to apply with a separate form. Upon lodgment of their activity statement, the first amount will automatically be credited to the business' account, but no earlier than 28 April 2020. A business that lodges early will not receive the cash flow boost before this date.

The initial cash flow boost amount is based on the amount of your PAYG withholding. Eligible businesses that withhold tax on their employees' salary and wages will receive a credit equal to 100% of the amount withheld, with the following exceptions:

- Monthly lodgers will receive a credit for March 2020 which is 300% of their withholding for that month. This will provide an approximate equivalent to lodgers reporting quarterly.

- Eligible businesses will receive a minimum of \$10,000 across March to June 2020, even if their total withholding is less than \$10,000.

- Total cash flow boosts for March to June 2020 cannot exceed \$50,000.

If the business receive the minimum credit of \$10,000 they will not be eligible to receive any more cash flow boosts until their PAYG withholding exceeds \$10,000 over the eligibility periods.

Eligible entities who received initial cash flow boosts will receive additional cash flow boosts between July to October 2020. These will be delivered in either two or four instalments, depending on their reporting period. The amounts will be equal to the total amount of initial cash flow boosts received.

Who Can Apply

Eligible applicants include small or medium business entity, including not-for-profit organisations, sole traders, partnership, company or trust that:

- Held an ABN on 12 March 2020 and continues to be active.

- Has an aggregated annual turnover under \$50 million (generally based on prior year turnover).

- Made eligible payments they are required to withhold from (even if the amount they need to withhold is zero).

In addition, applicants must also have either:

- Derived business income in the 2018-19 income year and lodged their 2019 tax return on or before 12 March 2020.

- Made GST taxable, GST-free or input-taxed sales in a previous tax period (since 1 July 2018) and lodged the relevant activity statement on or before 12 March 2020.



Charities registered with the Australian Charities and Not-for-profits Commission are eligible, regardless of when they were registered, if they meet the other eligibility requirements.

Eligible Activities

Eligible payments include:

- Salary and wages
- Director fees
- Eligible retirement or termination payments
- Compensation payments
- Voluntary withholding from payments to contractors

COVID-19 National: Business, Non-Profits, Individuals – Coronavirus SME Guarantee Scheme

StatusOpenFundingMax \$250,000LocationNational

Overview

This program aims to provide small and medium sized business with timely access to working capital to help them get through the impact of the Coronavirus. It seeks to enhance lenders' willingness and ability to provide credit, supporting many otherwise viable SMEs to access vital additional funding to get through the impact of Coronavirus.

The program forms part of the Australian Government's Economic Stimulus Package which aims to support households and businesses and address the significant economic consequences of the Coronavirus.

Under the scheme, the Government will support unsecured loans of up to \$250,000 to small and medium sized businesses:

- The loans will be available with a term of up to three years.

- A six month repayment holiday will be available on all loans.

- The loans will be unsecured, meaning that businesses will not need to provide an asset as security.

- A range of loan types may be made available, including overdrafts and term loans. Credit card facilities (including charge cards) are not eligible under the scheme.

- Interest rates will be determined commercially by lenders.

Loans backed by the scheme will be made available via commercial lenders. Businesses wishing to apply should contact their current financial institution or any other participating lender.

While the scheme officially commences from April 2020, the bank or other lenders may be able to provide credit sooner, and still benefit from the guarantee. If the SME's current financial institution is not participating, loans will be available via other lenders. Participating lenders are required to offer loans under the scheme to new customers.

The Scheme will be available for new loans made by participating lenders until 30 September 2020.

Who Can Apply

Eligible applicants include all active Australian businesses with turnover of less than \$50 million in the previous financial year, or expected turnover of less than \$50 million in the current financial year. Both self-employed individuals and non-profit businesses are eligible.

Eligible Activities

Loans must be used for business purposes only, and must be used to support current and upcoming cash flow needs (for example, rent and staff expenses).

COVID-19 National: Business – Tax Relief Measures

StatusOpenLocationNational

Overview

This program aims to assist Australians experiencing financial difficulty as a result of the COVID-19 outbreak.

Options available to assist businesses impacted by COVID-19 include:

- Deferring by up to four months the payment date of amounts due through the business activity statement (including PAYG instalments), income tax assessments, fringe benefits tax assessments and excise.

- Allow businesses on a quarterly reporting cycle to opt into monthly GST reporting in order to get quicker access to GST refunds they may be entitled to.

- Allowing businesses to vary Pay As You Go (PAYG) instalment amounts to zero for the March 2020 quarter. Businesses that vary their PAYG instalment to zero can also claim a refund for any instalments made for the September 2019 and December 2019 quarters.

- Remitting any interest and penalties, incurred on or after 23 January 2020, that have been applied to tax liabilities.

- Working with affected businesses to help them pay their existing and ongoing tax liabilities by allowing them to enter into low interest payment plans.

Employers will still need to meet their ongoing super guarantee obligations for their employees.

Assistance measures for those impacted by COVID-19 will not be automatically implemented. Anyone impacted by COVID-19 is advised to contact the ATO to request assistance on our Emergency Support Infoline 1800 806 218, when they are ready, to discuss their situation.

COVID-19 National: Business, Individuals – Support for Employees Working from Home

StatusOpenCloses30-06-2020LocationNational

Overview

This program aims to provide support to employees who are working from home due to the COVID-19 pandemic by allowing them to claim at tax time for the running expenses they incur.

To claim a deduction for working from home, all of the following must apply:

- The employee must have spent the money.
- The expense must be directly related to earning their income.
- The employee must have a record to prove it.

This means employees cannot claim a deduction for items provided by their employer or if they have been reimbursed for the expense. If they are not reimbursed by their employer, but instead receive an allowance from them to cover the expenses when they work from home, they:

- Must include this allowance as income in their tax return.
- Can claim a deduction as outlined in the Fact Sheet.

There are three ways to choose to calculate additional running expenses:

- Shortcut method: Claim a rate of 80 cents per work hour for all additional running expenses
- Fixed rate method claim all of these:

a) A rate of 52 cents per work hour for heating, cooling, lighting, cleaning and the decline in value of office furniture.

b) The work-related portion of the actual costs of phone and internet expenses, computer consumables, stationery.

c) The work-related portion of the decline in value of a computer, laptop or similar device.

- Actual cost method: Claim the actual work-related portion of all the running expenses, which the employee needs to calculate on a reasonable basis.

Eligible Activities

Eligible expenses that can be claimed include:

- Electricity expenses associated with heating, cooling and lighting the area from which the employee is working and running items they are using for work.

- Cleaning costs for a dedicated work area.
- Phone and internet expenses.
- Computer consumables (for example, printer paper and ink) and stationery.

- Home office equipment, including computers, printers, phones, furniture and furnishings – employees can claim either the:

a) Full cost of items up to \$300.

b) Decline in value for items over \$300.

Talent Grants

Overview

This program aims to support businesses working to counter the impact of COVID-19.

It's essentially an Upwork credit that businesses never need to pay back. If the project is selected to receive this grant, the Upwork team will match them directly with remote professional(s) who have the specialized skills they need, and the grant funds pay for some or all of their time to help propel the effort.

Grants of up to USD25,000 are available. The amount of each grant is determined based on each project's scope.

A total funding of USD1 million is available.

Who Can Apply

Eligible applicants include all types of businesses across the world.

Eligible Activities

Eligible projects include those whose mission is tied directly to mitigating COVID-19's devastating impact on individuals, communities and economies everywhere.

COVID-19 National: Business – Increasing the Instant Asset Write-Off

Status	Open

Overview

This program aims to assist Australian businesses and economic growth in the short-term, and encourage a stronger economic recovery following the Coronavirus outbreak. It is one of the investment measures provided by the Government in backing businesses to invest to help the economy withstand and recover from the economic impact of Coronavirus.

The program forms part of the Australian Government's Coronavirus Economic Stimulus Package which aims to keep Australians in jobs, keep businesses in business and support households and the Australian economy as the world deals with the significant challenges posed by the spread of the coronavirus.

The Government is increasing the instant asset write-off (IAWO) threshold from \$30,000 to \$150,000 and expanding access until 30 June 2020.

The higher IAWO threshold provides cash flow benefits for businesses that will be able to immediately deduct purchases of eligible assets each costing less than \$150,000. The threshold applies on a per asset basis, so eligible businesses can immediately write-off multiple assets.

The IAWO is due to revert to \$1,000 for small businesses (turnover less than \$10 million) from 1 July 2020.

Expanding the threshold will mean an additional 5,300 businesses who employ around 1.9 million Australians will be able to access the IAWO for the first time.

This measure is estimated to have a net cost of \$700 million over the forward estimates. It will support business investment and is estimated to lower taxes paid by Australian businesses by \$2.5 billion over the next two years.

Who Can Apply

Eligible applicants include all businesses with aggregated annual turnover of less than \$500 million up from \$50 million.

Eligible Activities

This proposal applies for new or second-hand assets first used or installed ready for use in this timeframe (12 March to 30 June 2020).

COVID-19 National: Business – International Freight Assistance Mechanism (IFAM)

StatusOpenLocationNational | Overseas

Overview

This program aims to help restore critical global supply chains for high-value Australian agricultural and fisheries producers, who have been heavily impacted by COVID-19 containment measures around the world. It forms part of the Australian Government's \$1 billion Relief and Recovery Fund which will support regions, communities and industry sectors that have been severely affected by the Coronavirus (COVID-19) crisis. The fund was announced as part of the Government's response to the economic impact of COVID-19.

Through the IFAM, the government is partially offsetting the cost of airfreight – reducing airfreight and freight forwarding costs for exporters and ensuring they can get their produce on flights and to international customers quickly. The mechanism is not intended to fully offset the increase in freight costs to pre COVID-19 levels, but by meeting a portion of the airfreight costs, the Government is helping ensure Australian exporters can recover and adapt quickly when COVID-19 crisis begins to abate.

Target countries and departure points will be determined by demand and freight optimisation criteria as advised by the International Freight Coordinator General:

- The mechanism will initially focus on the key markets of China, Japan, Hong Kong, Singapore and the UAE.

- The initial departure points for freight will be Melbourne, Sydney, Brisbane and Perth.

A total funding pool of \$110 million is available.

Exporters can express their interest by sharing their air freight requirements. Please visit the website for more information on <u>how to register</u>. The mechanism provides exporters certainty over the medium-term. It will operate until ordinary commercial markets return, or for six months, whichever is the earlier. If demand, value and need are clear, the mechanism may be extended.

Who Can Apply

Eligible applicants include Australian exporters in the agriculture and seafood sector.

Eligible Activities

Eligible products may include:

- Seafood, including lobsters
- Premium meat, including beef and pork
- Dairy, including fresh milk and yoghurt
- Horticulture, including premium fruits and packaged salad or vegetables

Given the economics of airfreight, low value products are not likely to be eligible. This will likely include:

- Products that are heavy, bulky and are conventionally shipped by sea.
- Exports to markets not open to airfreight.
- Export by airfreight that is not likely to be economically exported on an ongoing basis.

COVID-19 National: Business – Supporting Apprentices and Trainees

Status	Open

Funding	Max \$21,000
Location	National

Overview

This program aims to support small business to retain their apprentices and trainees during the Coronavirus health crisis. It forms part of the Australian Government's Economic Response to the Coronavirus which aims to to support households and businesses and address the significant economic consequences of the Coronavirus.

Eligible employers will receive a wage subsidy of up to 50% of the wage, reimbursed in arrears:

- Worth up to \$7,000 per quarter (to a maximum of \$21,000), per eligible apprentice or trainee.
- Available for a maximum of nine months, covering wages paid from 1 January 2020 to 30 September 2020.

Businesses that claim this subsidy for wages paid during the period 1 January 2020 to 31 March 2020 will not be precluded from applying for the JobKeeper Payment from 30 March 2020 – if they are eligible. After this time, they will need to choose which payment best supports their circumstances.

This measure will support up to 70,000 small businesses, employing around 117,000 apprentices.

Employers can register for the subsidy from 2 April 2020. Final claims for payment must be lodged by 31 December 2020.

A total funding pool of \$1.3 billion is available.

Who Can Apply

Eligible applicants include small businesses employing fewer than 20 employees who retain an apprentice or trainee. The apprentice or trainee must have been in training with a small business as at 1 March 2020.

Employers of any size and Group Training Organisations that re-engage an eligible out-of-trade apprentice or trainee will be eligible for the subsidy.

Employers will be able to access the subsidy after an eligibility assessment is undertaken by an Australian Apprenticeship Support Network (AASN) provider.

COVID-19 National: Business, Non-Profits, Individuals – JobKeeper Payment

StatusOpenFundingMax \$1,500LocationNational

Overview

This program aims to support businesses significantly affected by the coronavirus to help keep more Australians in jobs. It forms part of the Australian Government's Coronavirus Economic Stimulus Package which aims to support households and businesses and address the significant economic consequences of the Coronavirus.

Under the program, businesses or not-for-profits impacted by the Coronavirus will be able to access a subsidy from the Government to continue paying their employees. Affected employers will be able to claim a payment of \$1,500 per fortnight per eligible employee from 30 March 2020 until 27 September 2020.

Employers need to pay all eligible employees a minimum of \$1,500 (before tax) per fortnight to claim the JobKeeper payment. This will be paid to the employer in arrears each month by ATO. The first payments to eligible employers will commence in the first week of May 2020.

Businesses can enrol for the initial JobKeeper periods from 30 April 2020 until 31 May 2020 through the ATO's Business Portal, in ATO online services using myGov if a sole trader, or through a registered tax or BAS agent.

A total funding pool of \$130 billion is available.

Who Can Apply

Eligible applicants include employers who must meet the following requirements:

- On 1 March 2020, carried on a business in Australia or were a not-for-profit organisation that pursued their objectives principally in Australia.

- Employed at least one eligible employee on 1 March 2020.

- Their eligible employees are currently employed by their business for the fortnights the claim for (including those who are stood down or re-hired).

- Their business has faced a:
- a) 30% fall in turnover (for an aggregated turnover of \$1 billion or less).
- b) 50% fall in turnover (for an aggregated turnover of more than \$1 billion).
- c) 15% fall in turnover (for ACNC-registered charities other than universities and schools).

COVID-19 National: Business – Temporary Relief for Financially Distressed

Businesses

Status Open Location National

Overview

This program aims to provide support to profitable and viable businesses who are temporarily facing financial distress due to the economic impacts brought about by the spread of the Coronavirus. It seeks to ensure that these businesses have a safety net when the crisis has passed so they can resume normal business operations.

The elements of the package are:

1. Temporary higher thresholds and more time to respond to demands from creditors

- The Government is temporarily increasing the current minimum threshold for creditors issuing a statutory demand on a company under the Corporations Act 2001 from \$2,000 to \$20,000. This will apply for six months.

- The statutory timeframe for a company to respond to a statutory demand will be extended temporarily from 21 days to six months. This will apply for six months.

- The threshold for the minimum amount of debt required for a creditor to initiate bankruptcy proceedings against a debtor will temporarily increase from its current level of \$5,000 to \$20,000. This will apply for six months.

- The time a debtor has to respond to a bankruptcy notice will be temporarily increased from 21 days to six months. The extension will give a debtor more time to consider repayment arrangements before they could be forced into bankruptcy. This will apply for six months.

- When a debtor declares an intention to enter voluntary bankruptcy by making a declaration of intention to resent a debtor's petition there is a period of protection when unsecured creditors cannot take further action to recover debts. This period will be temporarily extended from 21 days to six months. This will apply for six months.

2. Temporary relief for directors from any personal liability for trading while insolvent

- Directors will be temporarily relieved of their duty to prevent insolvent trading with respect to any debts incurred in the ordinary course of the company's business. This will relieve the director of personal liability that would otherwise be associated with the insolvent trading. It will apply for six months.

- Temporary relief from personal liability for insolvent trading will apply with respect to debts incurred in the ordinary course of the company's business.

3. Providing the Treasurer an instrument making power under the Corporations Act

- To deliver regulatory certainty at a time when Parliamentary sittings will also be disrupted, the Treasurer will be given a temporary instrument-making power in the Corporations Act 2001 to temporarily amend provisions of the Act to provide relief from specific obligations or to modify obligations to enable compliance with legal requirements during the crisis.

- The instrument-making power will apply for six months. Any instrument made under this power will apply for up to six months from the date it is made.

For owners or directors of a business that are currently struggling due to the Coronavirus, the ATO will tailor solutions for their circumstances, including temporary reduction of payments or deferrals, or withholding enforcement actions including Director Penalty Notices and wind-ups.

Eligible applicants must satisfy one or more of the following requirements:

1. For Australian and New Zealand citizens and permanent residents

- On or after 1 January 2020, either:

a) Be made redundant.

b) The working hours were reduced by 20% or more.

c) If a sole trader, the business was suspended or there was a reduction in your turnover of 20% or more.

2. For temporary visa holders/residents

- Hold a student visa that they have held for 12 months or more and they are unable to meet immediate living expenses.

- Be a temporary skilled work visa holder, the working hours have reduced to zero and they remain engaged with their employer.

- Be a temporary resident visa holder (excluding student or skilled worker visas) and they cannot meet immediate living expenses.

Applicants will not be required to attach evidence to support their application; however, they should retain records and documents to confirm their eligibility.

This program aims to help renters by providing new rental waivers and deferrals for commercial tenants hit by the impact of the COVID-19 crisis.

The package includes the following measures:

- Landlords will have to reduce leases in proportion to the reduction in the tenant's business. The waivers will have to account for at least 50% of the reduction in business.

- Rent reductions will be based on the tenant's decline in turnover to ensure that the burden is shared between landlords and tenants.

- Evictions will be put on hold over the next six months for commercial and residential tenants in financial distress, who are unable to meet their commitments.

- Deferrals – rental payments that will need to be made, but can be put off – must be spread over the remaining time on a lease and for no less than 24 months. That means that if a tenant had three months remaining on a lease, they would still have at least a year to make any deferred rent payment.

- The Government is also waiving rents for all its small and medium enterprises and not-for-profit tenants within its owned and leased property across Australia.

The program also includes a mandatory code of conduct for commercial tenancies. The purpose of the Code is to impose a set of good faith leasing principles for application to commercial tenancies (including retail, office and industrial) between owners/operators/other landlords and tenants.

This code applies to tenants that are:

- A small to medium sized business with an annual turnover of up to \$50 million.

- Eligible for the <u>JobKeeper Payment</u>.

The Government's Rent Relief Policy applies from 24 March 2020 and will continue until the Australian Government lifts restrictions that are currently in place to slow the spread of COVID-19.

It will be available to all small and medium sized enterprises and not-for-profit tenants, subtenants and licensees that lease from non-corporate Commonwealth entities.

- The tax-free threshold will increase from \$900,000 to \$1 million for the financial year commencing on 1 July 2020.

COVID-19 QLD: Business, Non-Profits – State Land Rent Relief (COVID-19

Assistance)

Overview

This program aims to provide rent relief for holders of leases, licences and permits on state land, in response to the impact of COVID-19 pandemic.

Depending on their rental category, applicants may be eligible to receive a:

1. Rent waiver if they operate a business

- If receiving rental invoices quarterly, the government will waive the payment of rental invoices due in the following periods:

a) 1 April 2020 to 30 June 2020

b) 1 July 2020 to 30 September 2020

- If receiving rental invoices annually, the following arrangements apply:

a) If businesses have paid their annual rental invoice for the 2019-20 billing period, that part of the annual rental amount for the period 1 April 2020 to 30 June 2020 will be refunded to them. Their account will also be credited as long as they email ltladmin@dnrme.qld.gov.au by 15 May 2020.

b) The annual rent invoice for the 2020-21 billing period will be adjusted to remove the rental amount due from 1 July 2020 to 30 September 2020. This rent invoice will be sent on 1 November 2020 and payment will be due on 1 December 2020.

- If the calculated refund or adjustment results in the rental payment being lower than the minimum rent payable for the rental category , businesses will only receive a refund or adjustment down to the minimum rent.

- Businesses do not need to take any action to receive the rent waiver. The Department of Natural Resources, Mines and Energy will automatically waive the rent.

2. Rent deferral

- Under the proposed plans, those that are not eligible for a rent waiver and they receive rental invoices quarterly, their rent payable for the period 1 April 2020 to 30 June 2020 will be automatically deferred for payment until 1 September 2020.

- No action is necessary.

- Category 13 (business)
- Category 14.2 (large sporting and recreational clubs with over 2,000 members)

COVID-19 QLD: Business, Non-Profits, Individuals – Coronavirus Land Tax Relief

Overview

This program aims to support landowners who are impacted by the COVID-19 pandemic by providing land tax relief measures. These measures include:

- A land tax rebate reducing land tax liabilities by 25% for eligible properties for the 2019-20 assessment year.

- A waiver of the 2% land tax foreign surcharge for foreign entities for the 2019-20 assessment year.

- A three-month deferral of land tax liabilities for the 2020-21 assessment year.

Landowners do not need to apply for the foreign surcharge waiver or the three-month deferral. The Office of State Revenue will reassess land tax to apply the waiver and provide a refund where the assessment amount has already been paid. However, landowners will need to apply for the land tax rebate. Any land tax relief provided to commercial landlords must be passed onto eligible tenants.

Who Can Apply

Eligible applicants must be:

1. Landowners who lease all or part of a property to one or more tenants and all the following apply:

- The ability of one or more tenants to pay their normal rent is affected by the coronavirus (COVID-19) pandemic.

- Will provide rent relief to the affected tenant(s) of an amount at least commensurate with the land tax rebate.

- Will comply with the leasing principles even if the relevant lease is not regulated.

2. Landowners and all the following apply:

- All or part of their property is available for lease.

- The ability to secure tenants has been affected by the COVID-19 pandemic.

- Require relief to meet their financial obligations.

- Will comply with the leasing principles even if the relevant lease is not regulated.

If landowners are eligible for the land tax rebate under both the above circumstances, it is expected they will apply the rebate paid firstly to provide rent relief to their tenants. They can then apply any remaining rebate to their own financial obligations (e.g. in relation to debt and other expenses).

The land tax rebate will only apply to each property that meets the above eligibility requirements and conditions, rather than the rebate applying to entire taxable landholdings.

Where there are multiple tenants for a single property, including mixed-use developments, if the eligibility requirements and conditions are met for at least one tenancy, then the whole property is eligible for the land tax rebate.

COVID-19 QLD: Business, Non-Profits, Individuals – Relief for Commercial and Residential Tenants

Overview

This program aims to support landlords and tenants, both commercial and residential, impacted by the COVID-19 disaster.

Temporary legislative changes will be made to protect eligible tenants, including eviction moratoriums and rent freezes.

These measures include:

1. Relief for commercial tenants

- Any land tax relief provided to commercial landlords must be passed onto eligible tenants.

- The State Government is providing a range of support packages to businesses affected by COVID-19. These should be considered alongside support being provided by the Federal Government and private sector service providers including banks and utility companies.

2. Relief for residential tenants

- A crisis payment of up to \$500 a week for up to four weeks (\$2,000 maximum), is now available to Queenslanders who are homeless, or at imminent risk of becoming homeless and have exhausted these options:

a) Are renting a property currently or will shortly move into a new tenancy.

b) Have lost their job and have applied to Centrelink for the COVID-19 income support.

c) Are waiting for their application with Centrelink to be approved.

d) Have evidence negotiating a payment approach with their lessor/landlord directly, or via their property manager, as well as evidence of conciliation with the Residential Tenancies Authority but cannot reach agreement.

- Putting a freeze on evictions due to rent arrears for six months (from 29 March 2020) for Queensland tenants experiencing financial distress due to the impacts of COVID-19.

- For small and medium business enterprises, with a \$500 rebate off energy bills.
- This will be automatically applied on business electricity bills.
- 2. \$300 Million Household Utility Assistance Package

- This is in addition to the Government's Asset Ownership Dividend package, worth \$100 million, and will see households receive a \$200 utility payment to assist with electricity and water bills this year.

- The entire \$200 utility rebate – for both electricity and water costs – will be provided through the household electricity bill.

COVID-19 VIC: Business – Coronavirus Payroll Tax Relief

StatusOpenLocationVictoria

Overview

This program aims to provide payroll tax relief to businesses in response to coronavirus (COVID-19). It forms part of the Victorian Government's \$1.7 billion economic survival and jobs package, which has been developed to help Victorian businesses and workers survive the devastating impacts of the coronavirus pandemic.

There are two separate relief measures available:

1. Additional payments under the JobKeeper program are now exempt from payroll tax

- All businesses registered for payroll tax that make additional payments to employees as part of the JobKeeper program are eligible for this emergency relief measure.

- Any additional payments businesses make to bridge the gap between an employee's normal wage and the \$1,500 per fortnight required to qualify for JobKeeper payments are exempt from payroll tax:

a) For employees who have come to an agreement with their employer to be stood down and not perform any work, the full \$1,500 paid to them is exempt from payroll tax.

b) For employees paid less than \$1,500 per fortnight, the payroll tax exemption applies to the difference between their wage and the \$1,500. For example, to qualify for a JobKeeper payment, an employer must pay an additional \$500 to an employee who earns \$1,000 a fortnight. This additional payment of \$500 is exempt from payroll tax.

- Businesses do not need to apply for this emergency relief measure.

- Businesses that have already lodged their monthly returns for April 2020 and included additional payments in their estimated taxable wages can make adjustments as part of their payroll tax annual reconciliation in July 2020.

- The additional payments are not included in rateable remuneration for the purposes of calculating WorkCover Premiums.

2. Eligible businesses will have their payroll tax waived for the 2019-20 financial year

- Businesses with annual Victorian taxable wages up to \$3 million will have their payroll tax for the 2019-20 financial year waived.

- SRO will directly contact eligible businesses in relation to an emergency tax relief refund of payroll tax already paid in the financial year and will send eligible businesses more information about these relief measures.

- Emergency tax relief refunds will be made starting 27 March 2020.

- Eligible businesses must continue to lodge returns but do not need to make further payments for this financial year.

Businesses with annual Victorian taxable wages up to \$3 million can also defer, until January 2021, paying payroll tax for the first quarter of the 2020-21 financial year. The eligibility threshold applies to each employer, so any member of a group that pays Victorian taxable wages of less than \$3 million per annum is eligible for the relief. A total funding pool of \$550 million is allocated for this program.

This program aims to alleviate financial hardship faced by tenants and landlords as a result of coronavirus (COVID-19). It forms part of the Victorian Government's \$1.7 billion economic survival and jobs package, which has been developed to help Victorian businesses and workers survive the devastating impacts of the coronavirus pandemic.

For commercial tenants and landlords, the scheme will provide the following support:

- A six-month moratorium on commercial tenancy evictions for the non-payment of rent for small to medium enterprises with an annual turnover under \$50 million that have experienced a minimum 30% reduction in turnover due to coronavirus (COVID-19), commencing from 29 March 2020.

- A freeze on rent increases during the moratorium for commercial tenants.

- A rental payment waiver or deferral proportionate to commercial tenants' income reduction due to coronavirus (COVID-19), to be negotiated between the tenant and landlord.

- A mediation service for commercial tenants and landlords, accessed through the VSBC, to support fair tenancy negotiations.

The Government will also provide land tax relief to commercial or industrial landlords that provide rent relief to their tenants, provided:

- The tenant's annual turnover doesn't exceed \$50 million.
- The business is an eligible business in the Commonwealth's JobKeeper program.
- The business is suffering financial stress or hardship as a result of the pandemic.

The Government will also provide land tax relief to residential landlords who provide rent relief to eligible tenants.

A total funding pool of \$500 million is available.

Who Can Apply

Eligible tenants are those that qualify for the Commonwealth's JobKeeper program.

Tenants must be a small or medium sized business, including not-for-profits and sole traders, with annual turnover of up to \$50 million.

This program aims to provide land tax relief for commercial and residential landlords in response to coronavirus. It forms part of the Victorian Government's \$1.7 billion economic survival and jobs package, which has been developed to help Victorian businesses and workers survive the devastating impacts of the coronavirus pandemic.

There are two separate relief measures:

- Land tax relief for eligible commercial and residential landlords.

- Land tax relief for landowners with at least one taxable non-residential property and total taxable landholdings below \$1 million.

Commercial and residential landlords who meet the eligibility criteria for tax relief, can access a 25% discount on the land tax for that property, and choose to defer the balance of their assessment until up to 31 March 2021.

This relief is also available to land owners who are unable to secure a tenant (residential or commercial) because of coronavirus.

Eligible landlords can apply for the land tax reduction through My Land Tax from 1 May 2020. These landlords can also defer the remainder of their 2020 land tax to up to 31 March 2021. SRO will contact all eligible taxpayers in relation to this measure. Taxpayers do not need to do anything at this stage.

A total funding pool of \$420 million is available. As agreed by National Cabinet, these new measures will come into effect from 29 March for a period of six months.

Who Can Apply

Eligible applicants include landlords who must meet the following requirements:

- 1. If the property is rented
- The tenant's ability to pay their normal rent must be impacted by the coronavirus pandemic.
- If the tenant is commercial (includes retail, office and industrial), the tenant must be:
- a) A small or medium enterprise (annual turnover up to \$50 million).
- b) Eligible to receive the Australian Government's JobKeeper Payment.
- Both the landlord and tenant must have agreed to a reduced rent.
- The rent reduction (in dollar terms) must be at least 25% of the 2020 proportional land tax for that property.
- 2. If the property is not rented
- The property must be available for lease/rent.
- A tenant for the property cannot be secured because of the coronavirus pandemic.

For the tax deferral, a land owner must own at least one non-residential property and total taxable landholdings below \$1 million.

The Government is introducing three payroll tax measures:

1. Threshold increase

- The threshold will be increased to \$1 million on 1 July 2020. This replaces the previously announced increase planned for 1 January 2021.

- The threshold increase will be reflected in Revenue Online when it comes into effect in July.

- The initial threshold increase to \$950,000 that came into effect on 1 January 2020 is already reflected in Revenue Online for employers lodging monthly and quarterly returns. Employers who cancel their registration as a result of the increase will need to wait until the annual reconciliation function is available in August 2020 for adjustments to be made to their tax liability.

2. Defer payment of returns

- Small and medium businesses affected by the coronavirus (COVID-19) can apply to extend the time to pay their 2019-20 payroll tax until 21 July 2020.

- If the application is approved:

a) The payments will be deferred from the March return (due 7 April 2020) or the first return period after that date in which the business is affected.

b) Businesses may continue to lodge returns in Revenue Online without making payment.

c) For all deferred months, your returns must be lodged and your liability paid by 21 July 2020.

3. Grant payment

- A one-off grant of \$17,500 will be available for employers, or groups of employers, whose annual Australian taxable wages are more than \$1 million and up to \$4 million.

- For a group of employers, a single grant will be payable to the designated group employer.

- Eligible taxpayers do not need to apply for the grant.

- Grants will automatically be paid by cheque from July but there will be delays for taxpayers whose tax status changed in 2018-19 or who became liable for payroll tax during the 2018-19 or 2019-20 assessment year. Eligible taxpayers should log in to Revenue Online to ensure their postal address is correct.

Who Can Apply

Eligible applicants (for deferment of payment of payroll) include businesses who are:

- A non-grouped business with annual Australian taxable wages not exceeding \$7.5 million.

- A grouped business with the group's annual Australian taxable wages not exceeding \$7.5 million.

For the purposes of the program, a business is directly or indirectly affected if the current turnover, profit, customers, bookings, retail sales, supply contracts or other factors, compared with normal operating conditions, have been directly or indirectly affected by COVID-19.

ACT Programs COVID-19 ACT: Business – Waiver and Deferral of Payroll Tax

StatusOpenLocationAustralian Capital Territory

Overview

This program aims to support businesses impacted by COVID-19 pandemic by providing deferral and waiver of payroll tax. It forms part of the ACT Government's \$137 million Economic Survival Package which aims to support the ACT community through the public health emergency caused by the COVID-19 pandemic.

The package includes:

1. Six-month waiver of payroll tax

- All businesses whose operations are directly affected by the prohibited activites list such as gyms and indoor sporting venues, cinemas, beauty therapists and nail salons will be eligible to receive a six-month waiver of payroll tax from April to September 2020.

- For those who lodge their payroll tax return monthly, the first waiver will be applied to the March payroll tax return, which is usually payable by 7 April.

- For those who lodge their payroll tax return annually, the first waiver will be applied to their account when their return is received at the end of the 2019-20 financial year.

- Businesses will need to complete a <u>simple online application form</u> on the ACT Revenue Office website to confirm their eligibility.

2. Payroll tax deferral

- All ACT businesses with Australia-wide wages of up to \$10 million can defer their 2020-21 payroll tax, interest free until 1 July 2022.

- Eligible businesses will need to lodge their payroll tax returns as normal but will not be required to make the associated payment at the usual time. If the deferred amount is paid before 1 July 2022, no interest will be charged. Interest will be applied to any outstanding deferred amounts from 1 July 2022.

- For those who lodge their payroll tax assessment monthly, deferral can commence for their July 2020 payroll tax liability, which is usually payable by 7 August.

- For those who lodge their payroll tax assessment annually, they can defer payment of their full 2020-21 payroll tax liability, which is usually payable in July 2021.

- Businesses will need to confirm their eligibility by visiting the <u>payroll tax page</u> on the ACT Revenue Office website.

COVID-19 ACT: Business – Commercial Tenancy Relief

StatusOpenLocationAustralian Capital Territory

Overview

This program aims to provide relief for business tenants and owner-operated commercial properties who are affected with the Coronavirus crisis. It forms part of the ACT Government's Economic Survival Package which aims to implement a range of measures to reduce cashflow pressures in the short term for low income households and local small and medium businesses in the industry sectors that are most impacted by the COVID-19 pandemic.

There are three broad categories of business emerging through COVID-19:

- Category 1: Those who have been partially or not affected.
- Category 2: Those who have been significantly affected (at least 30 per cent reduction in business income).
- Category 3: Those who have to shut-down operations due to COVID-19 health restrictions.

Support is being provided through ensuring that the deferral or waiver of rates is targeted based on need which is assessed as per the above and will be targeted at properties with small AUVs.

Commercial landlords will need to play their part, cost-sharing or the deferrals of losses will be shared between Government, landlords, tenants and financial institutions.

Landlords and tenants should work together to reach an agreement that allows the business to bounce-back when the time is right. The ACT Government will appoint a Commercial Tenancy Mediator (Business Commissioner) to support and encourage commercial landlords and tenants to engage and negotiate mutually agreeable outcomes. Further details on this role are to be announced shortly.

The ACT Government will review rent charges for commercial tenants of ACT Government properties whose operations have been significantly impacted by COVID-19.

Commercial tenants that can demonstrate this may receive rental relief for up to six-months from 1 April 2020 will need to email ACT Property Group.

Rebates, Subsidies and Waivers)

Status Open

Location Australian Capital Territory

Overview

This program aims to support small to medium businesses who are impacted by the Coronavirus pandemic as they adjust to social distancing requirements and an expected downturn in the local economy. It forms part of the ACT Government's \$137 million Economic Survival Package which aims to support the ACT community through the public health emergency caused by the COVID-19 pandemic.

Assistance includes:

1. Business liaison team

- A business liaison phone line has been created to assist businesses understand the support available to them through the ACT Economic Survival Package and practical advice for businesses operating through changed arrangements due to COVID-19. The number businesses can call is: (02) 6205 0900.

2. Canberra business advice and support service

- The service supports small businesses to address the impact of recent events on their business and provide one-on-one business management advice.

- Business owners can receive up to four hours of fully subsidised, tailored advice and access online business development resources.

3. Food business registration, outdoor dining and liquor licensing fees

- Off licenced venues with gross liquor purchase value of below \$3 million per annum and licenced venues will receive a 12-month waiver of their food business registration and liquor licencing fees from 1 April 2020. Outdoor dining fees for 2020-2021 will also be waived.

- In cases where food business registration has been prepaid for more than one year in advance, an additional 12 months will be added to the license.

- Businesses do not need to contact Access Canberra or the Health Protection Service for this waiver to occur. This support will be applied automatically as part of the normal annual fee licencing process.

4. Other business fee waivers

- The government will waive fees for 12 months from 1 April 2020 for businesses that require an infection control licence such as beauty therapists, nail salons, tattoo parlours and dentists.

- Businesses do not need to contact Health Protection Services, this will automatically happen as part of the normal licencing process.

5. Vocational education and training - skills

- The ACT Government is providing support for the Vocational Education and Training Sector by increasing subsidies for apprenticeships and traineeships and other VET students to access nationally recognised training in areas linked to skills needs across a range of industries.

- Subsidies are provided directly to Registered Training Organisation and skills Canberra will make these adjustments automatically. No application is required.

6. CIT investment

- The government will fast track CIT's Study Work Anywhere Any Time project to help CIT move its teaching and learning online by July 2020.

- The expertise required to implement this project will be sourced from local SMEs, which will support the local industry and help keep high value technology skills in the region.

7. Support for the construction industry

- Businesses in the construction industry can defer their payroll tax liability for the six months from April to September 2020 to provide cashflow assistance to help them retain workers.



- No interest will be charged on deferred amounts until 1 September 2020, at which point the Government will assess the impacts of COVID-19 and determine if a further deferral period is required.

8. Electricity rebates

- Small business owners with electricity usage below 100 megawatts per year will see rebates of \$750 automatically applied to their next electricity bill in around June or July 2020.

- The rebate will apply regardless of whether customers are on standing or market offers.

- Businesses do not need to contact their electricity supplier as this will be automatically applied.

9. Rideshare and taxi vehicle licence fees

- The Rideshare vehicle licence fee will be waived for 12 months for rideshare operators from 1 April 2020 as part of the normal licencing processes.

- In cases where licences have already been prepaid 12 months in advance, an additional 12 months credit will be added to the license at the next due date.

- The ACT Government will also waive all government leased taxi plate fees, including wheelchair accessible taxis to help support this vital service. This initiative will help to keep taxis on the road.

- These fees will be waived automatically. Contact does not need to be made with Access Canberra on these fees.

- The government will also provide a one-off payment of up to \$5,000 to taxi operators who lease their taxi plates from private owners. This level of support is in line with that already being provided to taxi operators who lease government issued plates in the Territory.

10. Commercial general rates rebate

- Commercial property owners with an average unimproved value of \$2 million or less on their property are eligible for a rebate on their commercial rates fixed charge.

- Commercial rate payers will receive a credit of \$2,622 (equivalent to the annual fixed charge) to their 2019-20 general rates, in quarter four. This will be applied automatically.

- Where rate payers have paid in full or have a quarter bill less than the credit, this will be rolled over to the next bill.

- Commercial property owners will also not receive an increase on their 2020-21 Fire and Emergency Services Levy.

This program aims to support NT businesses impacted by the coronavirus outbreak to help stimulate the economy and keep Territorians in jobs. It forms part of the Territory Government's Jobs Rescue and Recovery plan in response to the coronavirus (COVID-19).

Grants of up to \$10,000 are available with no co-contribution requirement. For work valued at more than \$10,000, the co-contribution by the Territory Government is limited to \$10,000 on a dollar-for-dollar basis up to a maximum grant of \$20,000.

Each business is only eligible to receive one grant, and it can be used to complete one or two different jobs on the premises.

The program operates through a voucher system.

A total funding pool of \$20 million is available.

Who Can Apply

Eligible applicants include businesses or enterprises that:

- Are not an excluded recipient.

- Have its principal place of doing business physically located in the Northern Territory (NT).
- Service its customers or clientele from a shopfront premises.
- Offer goods and/or services to the public.

- Were offering its services wholly or substantially in the NT for at least one month at the time of applying for a grant.

Excluded recipient means individuals, not-for-profit and charitable organisations, public and private schools, private and public educational institutions, home based businesses, government agencies and government owned bodies, statutory corporations, and local government.

Eligible Activities

Eligible activities include the purchase of goods and services to make permanent physical improvements to a business (land and/or building) that help its operations and customer experience.

Applicants must not use a voucher with any other voucher or other benefit granted under any other program (whether an Australian Government or NT Government program) to pay for the same works. Eligible works include:

- Buying new equipment
- New shop fit outs
- Physical changes to attract customers

Eligible works must include a labour component and be carried out by an eligible business that is not related to the grant recipient.

Inverter upgrades, batteries and other electrical work that support energy efficiency are eligible works, as well as solar hot water installation.



Excluded works include:

- Security improvement works as defined under the Biz Secure and Alcohol Secure programs.
- Buying solar photovoltaic (PV) panels or installing solar panels (e.g. rooftop solar).
- Works that are to be carried out by the grant recipient on a 'do-it-yourself' basis.
- Works carried out by a business related to the grant recipient.

This program aims to help Northern Territory (NT) businesses that have experienced significant hardship as a result of the coronavirus (COVID-19) pandemic. It is designed to help reduce costs for local businesses and keep them open and operating now, as well as in the rebound and recovery phase once the coronavirus (COVID -19) crisis is over and restrictions start to lift.

The package is available to eligible businesses in addition to other support including the Jobs Rescue and Recovery plan, the Tourism Resilience Package and other NT Government and Australian Government initiatives.

Businesses able to demonstrate they have experienced significant hardship may apply to be listed on the Business Hardship Register. Once an eligible business has been placed on the Business Hardship Register they will receive a business hardship certificate.

The registration will enable businesses to apply for:

- Waiving or deferring payment of payroll tax.
- Reducing utilities bills.
- Providing incentives for commercial landlords to reduce rents.
- Reducing or deferring rates.
- Other relief which may be offered from time-to-time agreed to by the responsible minister.

An eligible business who can confirm hardship:

- Between 1 April 2020 and 30 June 2020 will be placed on the Business Hardship Register, and be eligible to apply for the Business Hardship Package for the period 1 April 2020 to 30 September 2020.

- Between 1 July 2020 and 30 September 2020 will be placed on the Business Hardship Register, and eligible to apply for the Business Hardship Package for the period 1 July 2020 to 30 September 2020.

Who Can Apply

Eligible applicants must :

- Be a legal entity and holds a valid Australian business number (ABN) as at 23 March 2020.

- Be a Territory enterprise.
- Not be a government agency, government owned body, statutory corporation, or local government.
- Have an annual turnover of no more than \$50 million.
- Have experienced hardship.

Hardship means the business has suffered a reduction in turnover of 30% or more due to coronavirus (COVID-19).

Commercial landlords who meet the criteria will also be eligible for support if they can provide evidence that they have negotiated in good faith with their tenants.

Applications from businesses that meet the intent and principles, but which are outside the parameters set out in the Terms and Conditions will be assessed on a case-by-case basis.



Assessment Criteria

The main assessment criteria include:

- The business is eligible for the <u>Australian Government's JobKeeper</u> initiative, and evidence of eligibility is able to be provided.

- The business has been deemed eligible for the Small Business Survival Fund.

- The business is able to show a reduction in turnover of more than 30%.

- If the business is a commercial landlord, they are able to show a reduction in turnover of more than 30% and that it has negotiated in good faith with all of their tenants for rent relief in line with the mandatory code of conduct for commercial tenancies, agreed to by National Cabinet.

This program aims to help Territory small businesses survive the physical distancing requirements in response to the coronavirus (COVID-19) pandemic. It is in addition to other support, including the Jobs Rescue and Recovery Package and the Tourism Resilience Package.

The fund has three goals:

- Help local businesses survive through the partial or full shut-down period. For example, support in meeting unavoidable fixed costs.

- Help local businesses adjust and adapt to take advantage of the new consumer environment. For example, expanding online services, takeaway and delivery.

- Prepare local businesses to take advantage of the rebounding economy when the coronavirus (COVID-19) crisis is over. For example, upgrading premises or upskilling staff.

Eligible businesses will be able to apply for four payments:

1. Immediate survival payment

- Provides an initial lump sum directed to businesses to help offset immediate cost pressures and provide time to plan.

- Payment amounts are:
- a) \$2,000 for businesses with only one full-time equivalent (FTE) employee (including sole traders).
- b) \$5,000 for businesses with 2 to 4 employees (FTEs).
- c) \$20,000 for businesses with 5 to 19 employees (FTEs).
- d) \$50,000 for businesses with more than 20 employees (FTEs).
- 2. Rapid adaption payment
- Provides:
- a) Up to \$1,000 for businesses with one employee (FTE).

b) Up to \$5,000 for other eligible businesses to offset costs incurred in adapting their current business model to suit restrictions.

- This payment is application-based and paid direct to the business.
- It will be paid on the provision of an appropriate invoice.
- 3. Operational boost payment

- Provides immediate cash boost to affected businesses to offset the costs of continuing to maintain the business.

- Payment amounts are:
- a) \$2,800 for businesses with only one employee (FTE), including sole traders.
- b) \$8,400 for businesses with 2 to 4 employees (FTE).
- c) \$16,800 for businesses with 5 to 9 employees (FTE).
- d) \$28,000 for businesses with 10 to 14 employees (FTE).
- e) \$42,000 for businesses with more than 15 employees (FTE).
- 4. Operational support payment

- Businesses with annual turnover greater than \$75,000 and who have received previous payments will be able to supply additional information on a fortnightly basis to enable these payments.

- Businesses must provide the number of FTE employees actively engaged in operating the business during the relevant two-week period prior.



- Employees who are stood-down or not undertaking any paid hours of work during that period will not be included as FTE.

- The number of FTE employees will be used as evidence of business activity and a nominal value of \$500 per FTE will be paid up to a maximum of \$15,000 per business per fortnight.

Businesses that have already applied for the initial immediate survival and rapid adaption payments will not need to apply for the new operational boost and operational support payments. The original application form will be used to determine eligibility for these two new payments.

A total funding pool of \$50 million is available.

Who Can Apply

Eligible applicants include Northern Territory (NT) businesses that meet all of the following criteria:

- A legal entity and holder of a valid Australian business number (ABN) as at 23 March 2020.

- A Territory enterprise.

- Usually operates in one of the industry sectors affected by the social gathering restrictions announced on 22 March 2020 and 24 March 2020.

- Has been significantly impacted by the physical distancing requirements in response to the coronavirus (COVID-19) pandemic - for example, staffing, turnover.

The following list includes those businesses specifically identified in the Australian Government social distance restrictions:

- Food, drink and retail
- Beauty and personal care services
- Entertainment venues
- Leisure and recreation

Please refer to the website for the complete list of defined industry sectors.

Assessment Criteria

The main assessment criteria include:

- The affected business must be operating in a defined industry sector.

- Demonstration of significant impact, in particular in relation to turnover, staffing levels and fixed and operational costs.

- Applicants will be required to provide appropriate evidence to support their application to the fund.

- Eligible recipients must comply with the NT Government's buy local policy requirements.

- Businesses that meet the fund's objective (section 1.1 of the Terms and Conditions), intent and principles will be assessed on a case-by-case basis.

COVID-19 SA: Business – Payroll Tax Relief

StatusOpenLocationSouth Australia

Overview

This program aims to provide tax relief to South Australian businesses affected by the Coronavirus crisis. It forms part the South Australian Government's Jobs Rescue Package which will provide immediate financial support and relief to those most affected by the COVID-19 pandemic.

Support available include:

1. Six month payroll tax waiver – businesses with Australian grouped wages up to \$4 million

- Business groups with annual Australian grouped wages of up to \$4 million will receive a six month payroll tax waiver.

- Eligible business groups will not be required to pay any payroll tax for the months of April to September 2020 (for the return periods of March 2020 to August 2020).

- Where businesses meet the criteria of Australian grouped wages below \$4 million for 2018-19 no application will be required – RevenueSA will notify these businesses through RevenueSA Online.

- Monthly payroll tax returns must still be lodged to capture wages for the month, with no payment to be made.

- The payroll tax waiver is expected to provide maximum assistance of \$84,150 over the six months to an estimated 2,400 business groups.

2. Six month payroll tax deferral – businesses with Australian grouped wages over \$4 million

- Businesses with annual Australian grouped wages above \$4 million that can demonstrate they have been significantly impacted by COVID 19 will, upon application, be able to defer payroll tax payments for the six months from April to September 2020.

- For these eligible businesses, payroll tax payments that were due to be paid from April to September will now be due in October 2020.

- Monthly payroll tax returns must still be lodged to capture wages for the month, with payment deferred to October 2020.

As the administrative arrangements are developed further information will be made available.

If a business is part of a group of companies that is registered for payroll tax and will receive the Government of South Australia payroll tax waiver for COVID-19 impacted businesses, the business is ineligible for this grant. Where the entity is not liable for payroll tax (such as a not-for-profit organisation), the payroll eligibility criteria of less than \$1.5 million in 2019-20 is to be based on total Australian group wages for the organisation.

- Seeking financial, legal or other advice to support business continuity planning.
- Developing the business through marketing and communications activities.
- Other supporting activities related to the operation of the business.

COVID-19 SA: Business, Non-Profits, Individuals – Land Tax Relief for Landlords

StatusOpenLocationSouth Australia

Overview

This program aims to support landlords who provide tenants impacted by COVID-19 with rent relief. It forms part of the South Australian Government's land tax relief package for their landlords who are significantly impacted by the COVID-19 pandemic.

Under the scheme, landlords may be eligible for a 25% reduction on the land tax payable on a parcel of land in the 2019-20 land tax year.

The relief is available when:

- The land is used for residential or non-residential (commercial) purposes.

- The land is being leased to either (i) a residential tenant, or (ii) a non-residential (commercial) tenant with annual turnover of up to \$50 million, who has been financially impacted as a result of the COVID-19 pandemic.

- The landlord reduces the rent of the affected tenant by at least as much as the land tax reduction.

- The land tax is directly related to the land for which the rent has been reduced.

Financially impacted is considered to be:

- For non-residential (commercial) tenants – a 30% drop in revenue due to COVID-19 and are eligible for the Australian Government's <u>JobKeeper Payment</u>.

- For residential tenants – financial hardship due to COVID-19. Further information will be available as part of the application process.

This relief is also available to residential and non-residential land owners who are unable to secure a tenant because of COVID-19.

Land tax relief is limited only to land occupied by affected tenants or vacant due to the impact of COVID-19.

Landlords who have already fully paid their 2019-20 land tax liability and are eligible for relief under this scheme will be issued a refund equal to the value of eligible land tax relief.

This measure is in addition to the land tax instalment deferral measure.

Applications for this relief will be open until the end of June 2020 and details on the application process are being finalised and will be available shortly.

Who Can Apply

Eligible applicants include landlords who must demonstrate that the land was leased to 30 March 2020, but has since been vacant due to the impact of COVID-19.

- The activity creates broader economic benefits for the community and multiple entities, including entities not directly associated with the application.

- The activity contributes to the scale of an industry or sector.
- The activity creates sustainable economic benefits to the State or region.

- Fits under one of the streams of the South Australian Economic Growth Agenda, Growth State – Trade and Investment; Skills and Innovation; Land, Water and the Environment; and Infrastructure.



2. Desirable - Also considered favourable are project proposals:

- That leverage funds from non-State Government sources and/or foster collaboration.

- That demonstrate a commitment to employing locally, local investment and local supplier inputs wherever possible.

- That provide matched or additional funding to achieve project outcomes or activity.

Businesses and individuals paying land tax quarterly in 2019-20 will be able to defer payment of their:

- Third Instalment: Defer payment up to six months from the due date.
- Fourth Instalment: Defer payment up to three months from the due date.

While businesses and individuals will be sent their land tax notices of assessment as usual, no application process will be required. There is no requirement to contact RevenueSA to put this new arrangement in place.

The deferral does not relate to previous outstanding arrears.

The previously announced land tax reform transitional relief fund available to eligible taxpayers whose land tax bill will increase as a result of the changes in aggregation of land commencing from 1 July 2020 will be increased from 50% to 100% of the increase in an eligible taxpayer's 2020-21 land tax assessment. This will be subject to the existing criteria.

There is no co-contribution financial payment required by the business owner/employing organisation, however RTOs may choose to charge an additional fee over and above the subsidy provided by Skills Tasmania.

A total funding pool of \$1.5 million is available.

Eligible applicants include endorsed registered training organisations (RTOs) that must be in partnership with an employer or an industry association and meet the following requirements:

- The Endorsed RTO must have the qualifications/skill sets/units of competency on their scope of registration.

This program aims to assist eligible businesses for the purpose of supporting business continuity, viability and sustainability during the Coronavirus period. It forms part of the Tasmanian Government's stimulus package which aims to support Tasmania as the state tackle the impact of the COVID-19 pandemic.

Support is available for eligible businesses in Tasmania that operate in the hospitality, tourism, seafood production export, related supply chain businesses, as well as businesses in other sectors of the economy that that can demonstrate they have been materially impacted by the Coronavirus outbreak.

Loans from \$20,000 up to \$250,000 are available under the following terms:

- The term of the loan is up to five years.

- Loans will be interest free for the first three years then payable at TDR's commercial loan rate from year four onwards.

- The commercial loan interest rate will be reviewed on a regular basis.

- The loan is repayable in full after five years.

- Loans within the core parameters of the scheme will be provided on an unsecured basis.

There are no loan application fees. Successful applicants under the scheme will only be responsible for legal fees, if required, and other statutory costs.

Who Can Apply

Eligible applicants must:

- Be majority Tasmanian owned and operate in Tasmania as a sole trader, trust, partnership or private company.

- Tasmanian Incorporated Associations that operate business undertakings that exist for the purpose of generating income streams will also be eligible to apply (at the department's discretion).

- Demonstrate their business has been impacted by the Coronavirus outbreak, as well as a clear need for the loan, to the satisfaction of the Department of State Growth.

- Demonstrate financial viability of the business prior to the Coronavirus.
- Be registered for tax purposes in Australia with an Australian Business Number (ABN).

- Require business financial reporting to a satisfactory level with satisfactory financial accounts and tax returns completed (with 2019 being highly preferred).

- Require a satisfactory credit history including the payment of statutory and staff entitlements.

- Have an annual turnover of \$10 million or less. Consideration will be given by exception to businesses that turnover in excess of \$10 million per annum and operate in multiple locations.

Eligible Activities

Eligible activities include:

- Purchase of business plant and equipment.
- Improving distribution channels and online shopping accessibility.
- Implementing initiatives to improve the sustainability and viability of the business.
- Ensuring that essential business continuity is maintained.

Applications are not eligible for payment of:

- Overdue creditor payments.
- Overdue statutory payments.
- Staff displacement or redundancy costs.
- Debt refinancing.

COVID-19 TAS: Business – Business Vehicle Registration Relief

Overview

This program aims to support Tasmanian small businesses who are significantly impacted with the Coronavirus crisis by providing business vehicle registration savings and deferrals. It forms part of the Tasmanian Government's stimulus package which aims to support Tasmania as the state tackle the impact of the COVID-19 pandemic.

Assistance available are:

1. Registration freeze for light and heavy vehicles

- Small businesses looking to suspend activity due to the COVID-19 business downturn and trading restrictions can apply to the Registrar of Motor Vehicles to freeze their business vehicle registrations for both light and heavy vehicles.

- Registrations can be reactivated at no cost to them when the business restarts.

- The maximum period that a registration can be frozen is 12 months.

2. Heavy vehicle registration and motor tax waivers

- For heavy vehicles of over 4.5 tonnes the government will waive fees for registration and the road component of motor tax for 12 months.

- Operators will still need to pay the regulatory component of motor tax which goes to fund the operations of the National Heavy Vehicle Regulator (NHVR).

A total funding pool of \$9.7 million is available.

Applicants are encouraged to contact Registration and Licensing Services for advice on eligibility or for assistance with their application.

This program seeks to assist COVID-19 affected small businesses in the identified severely impacted industries. It forms part of the Tasmanian Government's stimulus package which aims to support Tasmania as the state tackle the impact of the COVID-19 pandemic.

The most severely impacted industries include seafood; tourism and accommodation; retail; hospitality; arts and entertainment; fitness; plus:

- a) Suppliers to the above sectors (who derive the majority of their income from the above sectors).
- b) Exporters (any business who in 2018-19 derived the majority of the income from international exports).

As part of the Tasmanian Governments continued support to Tasmanian businesses, a second round of the Small Business Emergency Support Grant has been released to support businesses under severe hardship and who have not yet received funding under the first round.

Grants of up to \$2,500 are available per eligible small business.

Businesses may only submit one application per ABN. All applicants are recommended to register for the Australian Government's <u>JobKeeper payment</u>.

Who Can Apply

Eligible applicants must:

- Have been employing fewer than 25 full time equivalent (FTE) employees (casual, part-time or full time), on or before 31 January 2019, or be a:

- a) A sole trader
- b) Non-employing business
- c) Owner operator
- Meet the hardship test of a loss in revenue of greater than 30%. Evidence may be required to be provided.

- Derive greater than 50% of their income from the business. Noting that requests may be made to applicants to provide documented evidence to demonstrate this.

- Have been operating their business (not a hobby or charity) on or before 31 January 2019.
- Be registered for tax purposes in Australia with an Australian Business Number (ABN).
- Be a majority owned and operated Tasmanian business.

The following are ineligible to apply:

- Businesses who have already received funding under round one.
- Wholly owned subsidiaries of large businesses (25+ employees).
- A non-employing business from which the owner derives less than 50 per cent of their income.

- Not-for-profit organisations, unless trading or funding activities are a substantial part of the organisations activities.

- Businesses who are eligible for the Primary Healthcare Grants.
- Businesses who submit multiple applications under one ABN.
- Unincorporated associations.

Grants of up to \$15,000 are available. Grant amounts will be based on evidence provided that demonstrates a loss in revenue greater than 30%.

A total funding pool of \$20 million is available. Applicants are encouraged to apply for the <u>Small Business</u> <u>Emergency Support Grant</u> first.

Who Can Apply

Eligible applicants must:

- Have been employing 49 full time equivalent (FTE) employees or less (casual, full-time or part-time), as at 31 January 2020.

- Meet the hardship test and provide documented evidence to support a loss in revenue of greater than 30%.

- Have been operating their business (not a hobby or charity) on or before 31 January 2019.

- Be registered for tax purposes in Australia with an Australian Business Number (ABN) and be registered for GST.

- Be a majority Tasmanian-owned and operated business in Tasmania.

The following are ineligible to apply:

- Businesses not registered for GST
- Local State or Australian Government entities
- Not-for-profit organisations, unless trading or funding activities are a substantial part of the organisations activities

- Unincorporated associations

Assessment Criteria

The main assessment criteria include the applicant's ability to demonstrate:

- Severe hardship and meet the hardship test. A business must demonstrate that its revenue has reduced by more than 30%.

- To continue to operate in the current environment and provide products or services necessary for the Tasmanian or Australian community.

- The need to temporarily cease operation but can demonstrate strong prospects for future jobs sustainment or growth.
