Advocacy Action

At the February General Meeting the Council adopted an Advocacy Action Plan. Council wanted to let the community know what they can expect from the Council in relation to our advocacy efforts on your behalf and we encourage you to hold us to account.

Mayor Bawden said "while putting together the Advocacy Action Plan we picked up some of the items covered in the Carpentaria Community Plan 2012-2022 that are progressed through the advocacy efforts of the Council, on behalf of the community. Now that 2022 has rolled past we wanted to pick those Focus areas up in this Advocacy Action Plan to ensure they were not lost, and Council will continue to advocate on behalf of the Communities."

"Your Council is committed to providing a good quality lifestyle in the Gulf and we often need the other levels of Government to provide the additional services that also contribute to that quality lifestyle. Councils with their very limited rate base are not able to be all things to all people and while we often become the providers of last resort we cannot control those important things like health, education, and aged care," he said.

The Advocacy Action Plan sets out what the Council will do in relation to those matters which the Council has no jurisdiction. Those things like education, health, aged care, which are the responsibility of the other levels of Government, but those things that also matter most to members of the community and ultimately ensure we have a good quality of life and access to services that people in larger populated centres take for granted.

No Excuse for Abuse.

At the February Meeting held in Normanton on Wednesday 15th February, Council was presented with a new Policy for consideration and adoption in relation to abuse against staff members from members of the community.

In recent months the level of abuse and disrespect shown towards our staff had increased to a level that the development of this policy was considered necessary.

Council endorsed the policy, and we will start to inform the community of its intent and the provisions contained in the policy.

Carpentaria Shire Council staff are brothers and sisters, uncles and aunts, mums, and dads, some are even grandparents; they are members of the community, they often help with sporting and community groups, volunteer and are part of the community they live in. Our staff don't deserve to be treated with aggression, abuse, and disrespect.

This policy is being developed to protect our staff and create a more respectful relationship between members of the public and the Carpentaria Shire Council employees.

Our staff will continue to provide service to the community that they serve in a respectful manner and record as much detail as possible of instances of abuse.

Community members can assist by treating staff with respect and refrain from any type of abusive behaviour.

There is no excuse for abuse.



Community Plan - Report Card

In 2012 the Council adopted a Community Plan outlining the Focus for the Council for the 10 years from 2012 through to 2022. As 2022 has now drawn to a close we have prepared a Report Card outlining the achievements to date and identifying those areas that still require focus and advocacy.

The Report Card provides a red, yellow, green highlight on the community comments and the Focus areas identified from 10 years ago. The Community Plan was required to be adopted by Council under legislation but in 2015 the requirement to have a 10-year plan was removed from the legislation.

Council has adopted the Report Card to provide feedback to the community members who contributed to its development and to ensure the community that plans such as this do not just become dust collectors and are utilised to plan and provide for the community.

Mayor Jack Bawden said "the Focus areas that still require implementation and advocacy efforts from the Council will be picked up in the Tourism Strategy, Economic Development Strategy and a new Advocacy Action Plan."

"There are many great initiatives that still remain a Focus for Council and these continue to be worked on and will not be lost now that 2022 has passed", he said.

We want to thank the many community members who contributed to the development of the Community Plan in 2011 and 2012 and especially thank the children who contributed the drawings of what they wanted their Shire to look like.


