#### **Executive Summary:**

The report is to advise Council of relevant planning and building activities within the Shire. Normanton Vehicle Hire & Accommodation is sending an application under the Land Act 1994 to acquire a 291m2 portion of Street Reserve (State Land) in front of their property along Airport Road.

Prior to the lodgment of the application, Normanton Vehicle Hire & Accommodation will need Council's Road Manager or Trustee of the reserve to sign each plan, and that Council has no issues to the acquisition.

#### **RECOMMENDATION:**

Council supports the acquisition of 192m2 Street Reserve on Airport Drive as per plan 25080/ROL/01 by Normanton Vehicle Hire & Accommodation.

#### **Background:**


Normanton Vehicle Hire & Accommodation are planning to extend their accommodation business located at the corner of Wurrup Street and Airport Road. To make their venture work they need an additional 5.3m of Street Reserve.

There are no Council or other Utility services located within the portion of land they wish to acquire.

They have engaged Ausnorth to assist with their application to acquire land under the Land Act 1994 over State Land. The final decision to sell the land will be made by the Department of Natural Resources and Mines, Manufacturing and Regional and Rural Development.
